*I understand that the following bylaw provision of Aspire North REALTORS® applies to all REALTORS® and Affiliate Members:*

## **ARTICLE VI - Privileges and Obligations**

### **Section 1**

The privileges and obligations of members, in addition to those otherwise provided in these bylaws, shall be specified in this Article.

### **Section 2**

Any member of Aspire North may be reprimanded, fined, placed on probation, suspended, or expelled by the Board of Directors for a violation of these Bylaws and Association Policies consistent with these Bylaws, after a hearing as provided in the Code of Ethics and Arbitration Manual of Aspire North. Although members other than REALTORS® are not subject to the Code of Ethics nor its enforcement by Aspire North, such members are encouraged to abide by the principles established in the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS® and conduct their business and professional practices accordingly. Further, members other than REALTORS® may, upon recommendation of the membership committee, or upon recommendation by a hearing panel of the Professional Standards Committee, be subject to discipline as described above, for any conduct, which in the opinion of the Board of Directors, applied on a nondiscriminatory basis, reflects adversely on the terms REALTOR® or REALTORS® and on the real estate industry, or for conduct that is inconsistent with or adverse to the objectives and purposes of Aspire North, the Michigan Association of REALTORS®, or the NATIONAL ASSOCIATION OF REALTORS®.

### **Dues & Fees Payment**

I understand and agree to pay the established dues, allocations, and fees, which are non-refundable and non-transferable. I acknowledge that my payment serves as evidence of my initial and ongoing commitment to abide by the rules and regulations, as they may be amended from time to time.
